Avery's primary job is to provide emotional support for crime victims and witnesses.

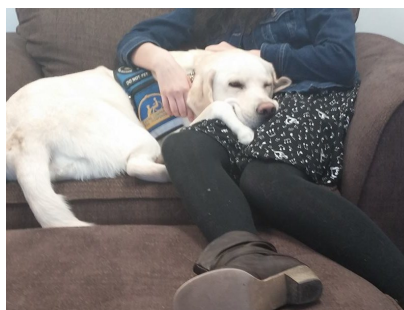

Watch Out For Health-Aid Scams!

Often, senior citizens seek home health care givers to help them with their day-to-day activities, such as general housekeeping, shopping, meal preparation and assisting with personal hygiene.

Unfortunately, sometimes home health aides can be more trouble than help. They can scam you out of jewelry, cash, credit cards and other valuables in your home without you even noticing. However, these scammers can be stopped!

- If you are looking to hire a home health aide, be sure to go through a licensed company that does background checks.
- Also, consider installing cameras in your home to monitor any suspicious activities.
- Do not leave your valuables in plain sight and do not tell your home health aid where you keep your wallet, purse, checks or credit cards.
- Monitor your bank statements often. Any fraudulent or suspicious transactions?

Sexually Transmitted Diseases Increasing Among Seniors

Close to 2,550 cases of syphilis were reported among adults in 2010 - up by 900 reported cases recorded in 2000. So who are included in those numbers? According to the CDC, adults between the ages of 45 and 65 are increasingly exchanging STD's. According to a 2010 Indiana University report, people 45 years and over have the lowest rate of condom use.

While moving into a nursing home or assisted living facility might be a necessity, it is important to practice safe-sex regardless of age. STD's are increasing in those facilities at an alarming rate. One of the best ways to prevent STD's is speaking with your doctor about safe-sex practices. Take care of yourself, and your partner.

Safeguard Your Finances

My office is seeing too many cases where an elderly victim is being taken advantage of financially by a family member. The suspect agrees to help with check writing to pay bills and then all of a sudden they are traveling to Vegas and Florida on the victim's credit cards or checking account. The victim's ATM cards are being used for everyday purchases.

My suggestion is if you have a family member helping you pay bills, have another trusted family member or friend check your finances to make sure your money is being used properly.
