PURPOSE OF EVENT: _____

THE FOLLOWING MUST BE COMPLIED WITH:

1. A RESPONSIBLE ADULT MUST BE PRESENT DURING THE DURATION OF THE FIRE.
2. A GARDEN HOSE CONNECTED TO A WATER SUPPLY OR A FIRE EXTINGUISHER MUST BE READILY AVAILABLE WHICH WILL BE CAPABLE OF EXTINGUISHING THE FIRE.
3. THE BONFIRE SHALL CONFORM TO THE FOLLOWING REQUIREMENTS:
 - A. SHALL NOT EXCEED 5 FEET BY 5 FEET IN SIZE.
 - B. SHALL NOT BURN LONGER THAN 4 HOURS PERMITTED.
 - C. SHALL NOT BE LOCATED CLOSER THAN 50 FEET TO ANY STRUCTURE.
4. BURNING WILL ONLY BE PERMITTED BETWEEN 7PM & 11PM ON THE DATE APPLIED FOR.
5. BURNING MATERIAL MUST BE DRY SEASONED FIREWOOD FOR A RECREATIONAL FIRE, PROVIDED, HOWEVER, A SMALL AMOUNT OF PAPER AND/OR BRUSH MAY BE USED TO START THE FIRE AS KINDLING.
6. IF AT ANY TIME, THE FIRE IS FOUND TO BE A NUISANCE TO PERSONS ON NEIGHBORING PROPERTIES, THE FIRE SHALL BE IMMEDIATELY EXTINGUISHED.
7. THE FIRE SHALL BE EXTINGUISHED WHEN UNATTENDED.
8. THE FIRE REMAINS MUST BE CLEANED FROM THE BONFIRE SITE BY 12 NOON THE FOLLOWING MORNING. IF THE SITE IS NOT CLEANED BY 12 THE FOLLOWING MORNING, THE PERSON OBTAINING THE PERMIT WILL BE FINED A \$500 LITTERING FEE.
